The Anti-Ragging Squad shall work in coordination with the Anti-Ragging Committee and oversee the implementation of the recommendations.

4) Punishments:

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institute, the possible punishments for those found guilty of ragging at the Institute level shall be any one or any combination of the following:

- 1) Cancellation of admission.
- 2) Suspension from attending classes.
- 3) Withholding / withdrawing scholarship / fellowship and other benefits.
- 4) Debarring from appearing in any test / examination or other evaluation process
- 5) Withholding results.
- 6) Suspensions/ expulsion from the hostel.
- 7) Rustication from the Institute for period varying from 1 to 8 semesters.
- 8) Expulsion from the Institute and consequent debarring from admission to any other Institute/ University.
- 9) Rigorous imprisonment of three years and / or a fine of uptoRs. 25,000/-
- 10) Collective punishment: When the person committing or abetting the crime or ragging are not identified, the Institute shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggars.

As per the instruction of UGC / Hon'ble Supreme Court of India, each of the student of the Institute and his/her parents and, or Guardian are hereby required to submit an Affidavit at the time of registration/ admission, in the prescribed format as attached to this order, which is mandatory for registration/admission.

Note: Smoking in and around the Institute is prohibited consuming/carrying of Alcohol/Narcotics and weapons are strictly prohibited.
